correct answer: if you have been rated out of living in the city as san francisco or new york, vermont wants you to consider it an alternative. in a new program that will begin next year, the state will pay the transfer costs for workers who get jobs at the companies vermont. This is a variation on another program, launched earlier this year, which refunds remote workers up to \$10,000 when moving to the state. the governor should sign the new program in law Wednesday. “In the last ten years, we have lost the population, and we have lost the workforce,” says joan goldstein, commissioner of the economic development department of vermont. the median age in the vermont is almost five years older than all the United States, and while the vermonters retire, the companies are struggling to find the employees. “We must recruit people to the state so that we get a little more net-migration and compensate for that ageing workforce.” People who are interested in moving can contact state officials through a program called thinkvermont, which can then connect them with local employers. It is not unusual that people consider the call to move to the state, goldstein says. (a cnbc report in 2018 classified vermont as the best place to live in the United States based on the natural environment, health, low crime and other factors; the state is also known for its local food, beers, fascinating cities and progressive politics.) but residents would often be worried about finding work. “Typically, you will say, “Well, what will I do in Vermont?”. “This is what was not immediately apparent. It is our job to make people understand that there are opportunities here. There are a number of employers who are looking for talented employees. “Works range from entry-level roles to software development locations or health locations. once someone is hired and moves, if the move happens after next January 1st, they will be able to invoice vermont for the displacement expenses. the program will pay up to \$5,000 in some areas, such as burlington, which have larger populations, and up to \$7,500 in most other smaller cities such as brattleboro or bennington. when the state began to give its current subsidies for remote workers, goldstein says that people were often interested in moving to small towns or villages. “Specially people from large metropolitan areas tend not to want to find in another metropolitan area,” he says. “They are looking for the country. “Other states and cities are testing similar programs. in rural kansas, some counties will pay \$15,000 student loan debt for recent grads moving. the small town of curtis, nebraska, pays theUp to \$ 1,000 and offers free land to those who want to build a home. A bill in Massachusetts would pay remote workers to move to the western part of the state. In Tulsa, remote workers can get \$ 10,000 in cash to try to live in the city, as well as a discount on the rent and a free free coworking Maine partners with some employers who pay the cost of a vacation in the state for visitors who later decide to move. In areas where populations are shrinking, it is likely that others will continue to make similar offers. ā “I think you can see more and more of this ā”” says Goldstein. ā”“We need to try harder and invent new and creative ways to attract people.Ā” NKF Advocates Working at the state level started 2021 with a bang, as the New Jersey legislature passed unanimously its Living Donor Protection Act (LDPA) at the end of January. One of the thirteen LDPA that NKF is bringing efforts to pass, is just one of several hits already this year. On February 4th and 22nd, homes in Pennsylvania and Kentucky surpassed their LDPAs. Since then, supporters of NKF have testified about their efforts in Connecticut and Washington. To ensure that we also address obstacles to obstacles, NKF is leading a new effort to reform kidney health policy by working with local and state legislators, as well as our kidney community partners in 11 states to introduce legislation to create kidney disease task forces. These efforts are already paying off, with our first hearing in Oregon scheduled soon. NKF is also supporting efforts to offer paid leave for organ donors and ensure that patients with end-state kidney disease are not discriminated against by Medigap insurers. Many state offices have also worked to ensure that states establish kidney patients and kidney care partners, along with residents of long-term care facilities and health care providers, in receiving access to Covid-19 vaccines. We have also fought to ensure that state governments prioritize the development of an infrastructure to support the dissemination of the COVID-19 vaccine to kidney patients to enable dialysis facilities and transplant centers to provide vaccine shots. Local NKF offices contacted governors and other key decision makers in 28 states where kidney patients and professionals reported difficulties in acquiring and distributing vaccines. These states include North Carolina, where NKF has led more than 100 organizations and professionals in a coalition letter to the governor to protest patients who have been downgraded to State 4 for access to the vaccine. In New York, we are working with practitioners across the state to send an additional letter of access to reinforce the need for kidney patients to gain access to doses of the vaccine, due to the serious deficiency reported there. The most recent NKF serving South Carolina submitted a letter to the state legislature at a hearing on vaccine access on February 17. Some laws say that doctors cannot withdraw or refuse vital support to a pregnant woman « or that such treatment cannot be refused if the fetus can be completed.
